Tender Notice

Sealed tenders in two envelope system are hereby invited by Bangladesh Services Limited (BSL) for Supply of paint materials and hardware including application of painting works with proper appliance in the interior and exterior area and cleaning of external window glass of the 7, 5 & 4-storied building of BSL Office Complex at 1, Minto Road, Dhaka-1000 from reputed bonafide and eligible firm/paint manufacturers having experience in similar type of works.

The intending firms/paint manufacturers must fulfill the following eligibility criteria for their participation in the tender.


2. a) Experience in successful completion of similar type of works in at-least one high rise building (minimum 7-storied) in a single contract in Bangladesh costing not less than Tk.20 lac during last 5 years.
- b) Possess certificates from the employers of their involvement as contractor in works of similar nature reflecting the volume of works, cost, date of issuance of work order and completion date of the work (Certificate(s) must be attached with the application).
- c. Should own equipment like Gondola or hanging type bamboo and rope made scaffolding, conventional scaffolding etc. safety net and other safety equipment to complete the work in all respect without interrupting the day to day activities of the complex.
- d) Possess documentary proof of bank solvency certificate.
- e) Should have valid trade licence, income tax clearance certificate for the financial year 2015-2016 and TIN No. and VAT registration certificate.

3. The intending firms/paint manufacturers while submitting application for purchase of Tender Documents will furnish a declaration on non-judicial stamp to the effect that they fulfill the eligibility criteria. Tender documents will be available in the office of the undersigned during the office hour from 03/12/2017 to 21/12/2017 on payment of Tk.5,000 (Taka five thousand only) (non-refundable) in cash to BSL.

4. Earnest money amounting to Tk.1,50,000.00 in the form of Bank Draft/Pay order from any schedule bank of Bangladesh located in Dhaka issued in favour of Bangladesh Services Limited shall have to be furnished along with the Tender Document without which the Tender shall be rejected outright.

5. The Technical Proposal and Financial Offer, submitted separately in sealed envelopes, which will be received in the office of the undersigned up to 4.00 PM of 24/12/2017 and the Technical Proposal will be opened at 4.30 PM on the same day at the same place in presence of the tenderers (if any). Financial Offers of only those firms will be opened, who would qualify in the evaluation of their Technical Proposal.

6. Bangladesh Services Limited reserves the right to accept any tender or reject any or all the tenders and increase or decrease the quantity of work, without assigning any reason whatsoever.
